No. AHSEC/RPR/RRC/57/06/ 1720 : As per recommendation of the Recognition Committee in its meeting held on 25.06.2013 & 26.06.2013 and subsequent approval of the Council in its meeting held on 06.07.2013, the ARONAI ACADEMY (JR COLLEGE), KOKRAJHAR is provisionally granted academic permission to start H S 1<sup>st</sup> Year Class in the stream and subjects as noted below w.e.f. the academic session 2013-2014 with the following condition(s).

<u>STREAM</u>	<u>SUBJECTS</u>
ARTS	English, MIL (Assamese, Bodo, Hindi, Bengali), Alternative English, Economics, Political Science, Education, History, Mathematics, Statistics, Computer Science & Application
SCIENCE	English, MIL (Assamese, Bodo, Hindi, Bengali), Alternative English, Physics, Chemistry, Biology, Mathematics, Computer Science & Application

**Conditions :**

- (i) Documents of Fund position to be submitted
- (ii) Bio-data of the Principal to be submitted
- (iii) The Institution shall have to run the classes in their own land as proposed within a period of 2 (two) years.
- (iv) Fire Extinguisher with certification from the competent authority is to be furnished immediately
- (v) Drinking water facility is to be provided for the students as per requirements
- (vi) Toilet facility is also to be provided for Girls and Boys separately
- (vii) Well furnished infrastructure for accommodating the students enrolled is to be ensured.
- (viii) Academic faculties should be engaged/appointed as per norms of the Council.

**NB:** 1. Non fulfillment of required conditions as per Council's norms to start the H S 1<sup>st</sup> year classes within the period of 2 years will be treated as cancellation for according 1<sup>st</sup> year permission.

2. No institutions can apply for 2<sup>nd</sup> year academic permission unless and until the conditions are fulfilled at the time of according 1<sup>st</sup> year permission
